HOSTING DEFINITION

Salco Sites will provide hosting for your website. Hosting, as it pertains to this contract, is defined as the business of housing, serving, and maintaining files for your website. In other words, Salco Sites assures that as long as payment is made, your site will be viewable on the internet. This does not guarantee that all aspects of your website will be viewable by all browsers, including mobile phone browsers. Salco Sites prefers and designs sites to be mainly viewed on Windows Internet Explorer, the most common browser used by the majority of users.

UPDATING DEFINITION

Salco Sites will provide general updating for you website. Updating, as it pertains to this contract, is defined as the general updating of images, text, and any other data that is already present on your website. In other words, Salco Sites assures that as long as payment is made, certain images, text, or other site add-ons, (as referred to and previously agreed on in the Website Features of the Website Design Agreement) will be updated without additional charges. This DOES NOT include any updating of your website that results in the adding of data or the adding of pages, which was not previously agreed to in the Website Features of the Website Design Agreement.

TERMS & PAYMENTS

This contract will expire one calendar year from the date signed below, and will be automatically renewed annually thereafter. The cost of hosting and updating is \$50 per month for Standard (business portfolio websites) and \$75 for Premium (multi-email/ecommerce websites). In addition to hosting and updating, your website will also be privately listed in the "whois" website registry, to prevent your website/email from receiving spam and any other non-authorized solicitation from outside third parties. After signing the Website Design Agreement, you will need to go to www.salcosites.com and set up your recurring monthly payment by clicking on the subscribe button for your hosting option. This service is provided through PayPal. Your first monthly payment will immediately be debited, making it so you are always paying a month ahead. Any returned payment will result in a \$25 insufficient fund charge by Salco Sites along with immediate suspension of your website, which if not rectified within 15 business days, will void **ALL** Salco Sites contracts, and you will be charged a \$300 termination fee.

RENEWAL & TERMINATION

Salco Sites will send a renewal notice to you two months prior to expiration of this contract. No action is needed if you wish to renew, and all the terms & conditions of this contract will be valid for another year, and so on annually. You may only terminate this contract upon renewal, by filling out the cancellation form accompanied with your renewals. This form must be received and acknowledged by Salco Sites 20 calendar days prior to renewal. Termination at any other time will result in a \$300 termination fee as mentioned above.
